TEXTBOOK

Definitive Book of Handwriting Analysis: The Complete Guide to Interpreting Personalities, Detecting Forgeries and Revealing Brain Activity through the Science of Graphology. The book has three sections: Part I: Behavioral Profiling; Part II: Neurophysiology of Handwriting; Part III: Questioned Documents. The main focus is the scientific examination of handwriting with direct application to questioned documents. For instance, the first section devotes 55 pages to the psychogram, which is a chart that measures 40 graphic variables on a 1-10 scale. This instrument thus has cross purposes. It can be used for behavioral profiling, scientific studies (because handwritings can now be converted to mathematical scores) and to questioned documents. Dr. Robert O'Block, founder of the American College of Forensic Examiners said of the book that it is "The best written on the subject in 10 years!"
